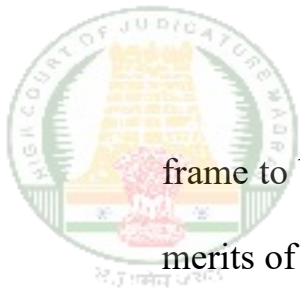
ORDER

frame to be fixed by this Court. This Court is not expressing any opinion on the merits of the petitioner's representation.
