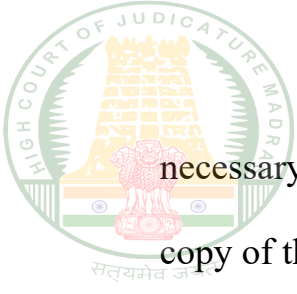


ORDER

necessary parties, within a period of twelve weeks from the date of receipt of a copy of this order. However, there shall be no order as to costs.
