4. Accordingly, this writ petition is allowed in terms of the order in W.A.No.1615 of 2018. It is needless to state that the petitioners would be entitled to the benefit of the order, subject to their specific eligibility criteria. No costs. Consequently connected miscellaneous petition is closed.
