ORDER

This writ petition has been filed to direct the respondents 2 and 3 to correct the FMB Sketch for the property morefully described in the prayer to this writ petition based on the petitioner's representation dated 18.03.2026 within a time frame to be fixed by this Court.

2. According to the petitioner, the present FMB sketch for the property is not in accordance with the sale deed standing in the name of the petitioner. In such circumstances, the petitioner seeks for correction of the FMB sketch. The petitioner had given a representation on 18.03.2026 to the respondents 2 and 3 for correction of the FMB Sketch. Since the said representation has not been considered till date, this writ petition has been filed.

3. Mr. S.Arumugam, learned Government Advocate accepts notice on behalf of the respondents.

4. No prejudice would be caused to the fourth respondent if the petitioner's representation as stated supra is considered on merits and in accordance with law after giving due consideration to the supporting documents



filed by the petitioner within a time frame to be fixed by this Court.
