This Writ Petition has been filed to direct the respondents to consider the petitioner's representation dated 01.12.2025.

2. Learned counsel for the petitioner would submit that the petitioner has made a representation dated 01.12.2025 before the respondents to remove the thar road laid on his land and to pay compensation or provide an alternate land to the same level. However, the said representation was not considered, as on date. Hence, this writ petition.

3. Mr.B.Pachaiyappan, learned Government's Counsel accepts notice on behalf of the respondents and submitted that the petitioner's representation dated 01.12.2025 will be considered within a period of twelve weeks.

4. Heard the learned counsel on either side and perused the materials available on record.

5. Considering the limited relief sought by the learned counsel for the petitioner, this Court without expressing any opinion on the merits of the case,



directs the second respondent to dispose of the petitioner's representation dated 01.12.2025, after issuing due notice to the petitioner and other aggrieved persons, if any, on merits and in accordance with law, within a period of twelve (12) weeks from the date of receipt of a copy of this order.
