WMP. No.15446 of 2026 is ordered subject to the payment of separate court fee.

2.This writ petition has been filed to direct the respondents to remove/delete the word 'Road' found in column No.18 of the Town Survey Land Register relating to the property, morefully described in the prayer to this writ petition and thereafter classify the same as private patta land belonging to the petitioners, within a time frame to be fixed by this Court.

3.According to the petitioners, the property morefully disclosed in the prayer to this writ petition are private patta lands. However, all of a sudden, the



respondents have classified a portion of the properties as 'road as found in Column No.18 of the Town Survey Land Register relating to the said property.

The petitioners have filed supporting documents along with this writ petition in support of their contentions. The petitioners had given a representation on 03.09.2025 to the respondents for the aforesaid purpose. Since the said representation has not been considered till date, the petitioners have filed writ petition.

4.Mr.D.Ravichander, learned Special Government Pleader accepts notice on behalf of respondents 1 to 4. Since no adverse order is being passed against the fifth respondent, notice to the fifth respondent is dispensed with by this Court.

5.No prejudice would be caused to the respondents if the petitioners' representation, as stated supra, is considered, on merits and in accordance with law, after giving due consideration to the supporting documents produced by the petitioners, within a time frame to be fixed by this Court.

6.This Court is not expressing any opinion on the merits of the petitioners' representation.



7. For the foregoing reasons, this writ petition is disposed of by directing the first respondent to pass final orders, on merits and in accordance with law on the petitioners' representation dated 03.09.2025 seeking for removal/deletion of the word 'Road' found in column No.18 of the Town Survey Land Register relating to the property, morefully described in the prayer to this writ petition and thereafter, classify the same as private patta land belonging to the petitioners, after giving due consideration to the supporting documents produced by the petitioners and after hearing all the necessary parties, within a period of 12 weeks from the date of receipt of a copy of this order. No costs.
