The Criminal Original Petition has been filed to quash the First Information Report in Cr.No.57/2025 dated 29.03.2025 on the file of the respondent police.

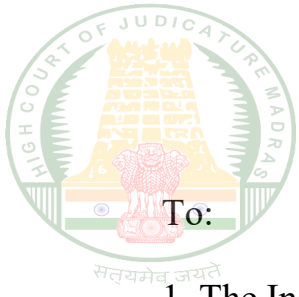
