4.Recording the same, this habeas corpus petition is closed. No costs.

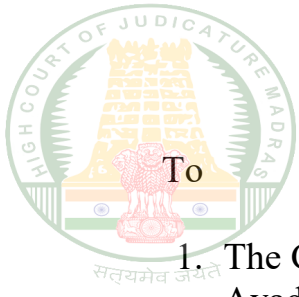
