3.The petitioners had submitted their online application dated 15.10.2025 for the aforesaid purpose. Since the same has not been considered till date, the petitioners have filed this writ petition.

4.Mr.D.Ravichander, learned Special Government Pleader accepts notice on behalf of respondents 1 to 4. Mr.V.Meganathan, learned Government Advocate (Crl.Side) accepts notice on behalf of the fifth respondent.



5.This Court is not expressing any opinion on the merits of the petitioners' application.

6.No prejudice will be caused to respondents 2 and 4 if the said authorities are directed to survey and demarcate the boundaries of the petitioners' property, morefully described in the prayer to this writ petition, after hearing the objections of the neighbouring land owners as well as any other party whom they deem it fit to enquire. Accordingly, this writ petition is disposed of in the following manner:-

(a) Before surveying the lands in question, the second respondent is directed to issue notice to the neighbouring land owners and also to any other party, whom they deem it fit to put on notice.

(b) After receiving objections if any and after considering the same, the fourth respondent shall conduct survey and demarcate the boundaries of the property morefully described in the prayer to this writ petition, on merits and in accordance with law, within a period of 12 weeks from the date of receipt of a copy of this order.

(c) If the need arises for police assistance and on a request made by the second respondent, the fifth respondent shall



render police assistance for the effective implementation of
this order. No Costs.
