ORDER

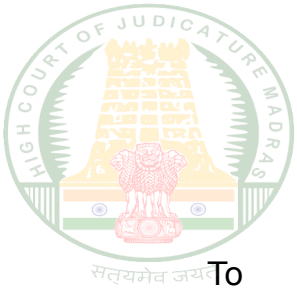
(Order of the Court was made
