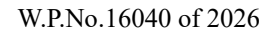

This Court is not expressing any opinion on the merits of the petitioner's representation, dated 14.03.2026.

For the foregoing reasons, this Writ Petition is disposed of by directing the 2<sup>nd</sup> respondent to pass final orders on merits and in accordance with law, on the petitioner's representation, dated 14.03.2026 seeking cancellation of pattas standing in the name of the respondents 4 to 6 in respect of the property morefully disclosed in the affidavit filed in support of this writ petition, after giving due consideration to the
