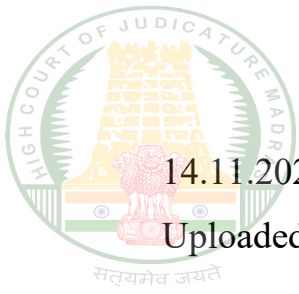

The Civil Miscellaneous Petition has been filed for extension of time for complying the order of this Court dated 19.09.2025.

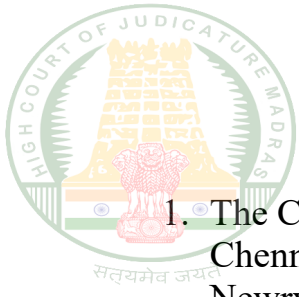
