This petition has been filed under Article 226 of the Constitution of India seeking a direction to respondents to consider petitioner's complaint dated 04.03.2026 and subsequent direction to set up Special Investigation team consisting of senior officers to investigate the illegal funding and corrupt practices in the upcoming Assembly Election in the State of Tamil Nadu.
