### **ORDER**

This Writ Petition has been filed challenging the impugned proceedings, dated 23.02.2026 issued by the 3<sup>rd</sup> respondent.

2. Mr.D.Ravichander, learned Special Government Pleader, accepts notice on behalf of the respondents 1 to 4. Since no adverse order is passed against the respondents 5 to 8 in this writ petition, notice to the respondents 5 to 8 is dispensed with by this Court.

This Court expressed its view to the learned counsel for the petitioner that the writ petition is not maintainable, since the 3<sup>rd</sup> respondent does not have the jurisdiction to consider the request of the petitioner. Learned counsel for the petitioner seeks liberty for the petitioner to file approach the civil court. He has also made an endorsement to that effect in the court bundle today.
