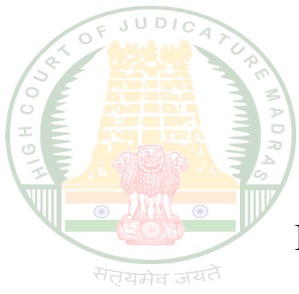

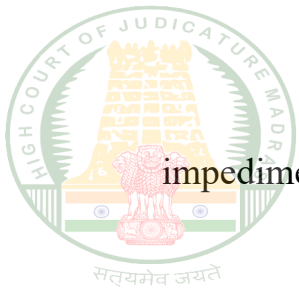
ORDER
