5. In reply, the learned counsel for the respondent would submit that the petitioner's representation will be disposed of within a period of 8 weeks and hence, he requests this Court to pass appropriate orders.

9. Post this matter for reporting compliance on 07.07.2026.

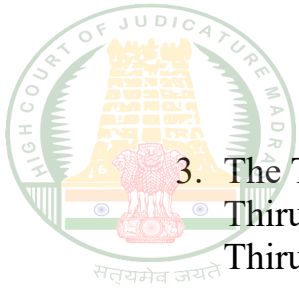
