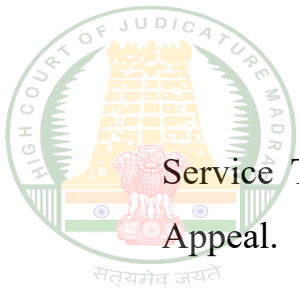

(Order of the Court was made by Dr.G.Jayachandran J.)

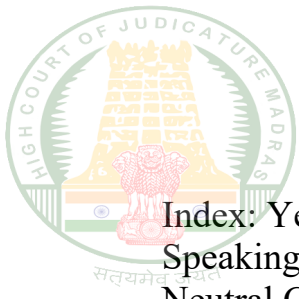
This petition has filed to condone the delay of 151 days in filing the Appeal in C.M.A.SR.No.208078 of 2025.
