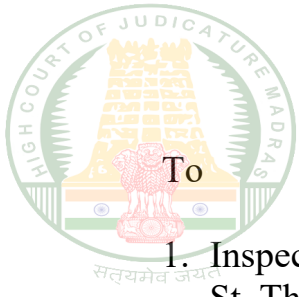
3. Recording the same, the writ petition is disposed of. However, liberty is granted to the petitioner to work out his remedy in the manner known to law.
