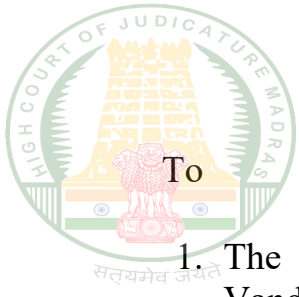
3. The learned counsel for petitioner submitted that he is not aware about serving of the RCS notice. He is certain that RCS notice served by force and compulsion.
