PRAYER

Writ Petition filed under Article 226 of the Constitution of India, praying to issue a Writ of Mandamus, directing the 1 to 3 Respondents to take action against the 4 to 11 Respondents to preventing the petitioner from accessing the common pathway situate in S.No. 406/1A to the extent of 1.35 cents situated at Reddiyur Village, Vaniyambadi Circle, Tirupattur District

ORDER

This writ petition has been filed to direct the respondent to consider the petitioner's representation dated 11.03.2024.



2. The learned counsel for the petitioner would submit that in this case, a representation was filed by the petitioner to take action against the 4 to 11 Respondents to preventing the petitioner from accessing the common pathway situate in S.No. 406/1A to the extent of 1.35 cents situated at Reddiyur Village, Vaniyambadi Circle, Tirupattur District. However, the said representation was not at all considered by the respondent till date. Hence, this petition.

3. In reply, the learned counsel for the respondent would submit that the petitioner's representation will be disposed of by the 2nd respondent within a period of 12 weeks.

4. Heard the learned counsel appearing for the petitioner and the respondent and also perused the entire materials available on record.

5. In view of the above, without expressing any opinion on the merits of the matter, this Court directs the 2nd respondent to consider the representation of the petitioner dated 11.03.2024 and dispose of the same, on merits and in accordance with law, within a period of 12 weeks from the date of receipt of a copy of this order.
