The required medical report/certificates are annexed to the Writ affidavit and Mr.Muniyapparaj, learned Additional Public Prosecutor, who accepts notice for the respondents will forward the same to the immediate attention of the prison authorities in order that the application for emergency leave on medical grounds will be considered expeditiously and disposed in accordance with the extant Rules, within two days (48 hours) from today.
