3. Admittedly, the petitioner's representation has been acted upon by the 3rd respondent, who has also conducted enquiry. However, till date, no final orders have been passed by the 3rd respondent on the petitioner's representation seeking correction of FMB sketch.

No prejudice would be caused to the respondents, if a direction is issued to the 3rd respondent to pass final orders on merits and in accordance with law on the petitioner's representation as stated supra, after hearing all the necessary parties, within a time frame to be fixed by this Court. This Court is not expressing any opinion on the merits of the petitioner's representation.
