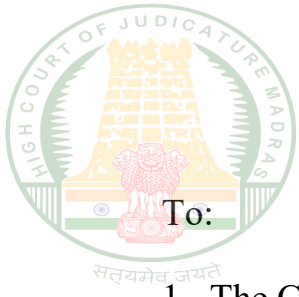
2. The learned Standing Counsel appearing for the respondents would submit that the orders of this Court has been complied with.
