ORDER

For the foregoing reasons, this Court directs the respondents 1 and 2 to pass final orders on merits and in accordance with law on the petitioner's representation dated 24.03.2022 after hearing the objections of all the necessary parties, which includes the rival claimants of the petitioner over the property which is the subject matter of this writ petition within a period of twelve weeks from the date of receipt of a copy of this order.

7. Accordingly, this writ petition is disposed of. No Costs.
