Alleging that the order of this Court dated 22.01.2026, made in W.P. No. 1662 of 2026 has not been complied with, the present contempt petition has been filed.

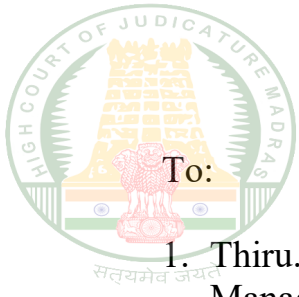
