COMMON ORDER

These Writ Petitions have been filed seeking issuance of a Writ of Certiorari and a Writ of Prohibition, seeking quashment of the impugned Notification dated 30.09.2024 bearing No.F.No.6/31/2024-DGTR passed by the first respondent and consequently to prohibit the first respondent from acting or proceedings further pursuant to the said impugned notification.

2. Both the learned counsel for the petitioner and the learned counsel appearing for the respondents would submit that the issue has become infructuous, as Central Government has not issued any notification levying Anti - Dumping Duty.



3. In view of the subsequent developments, these Writ Petitions stand dismissed as infructuous, leaving it open to the petitioner to raise all rights and contentions.
