**ORDER**

2.The petitioner, as complainant, filed a complaint under Section 138 of NI Act on 12.02.2026 and the same was registered in STC SR.No.2122 of 2026. It is almost 2 ½ months and still the complaint yet to be numbered, hence, filed this petition.

3.Considering that it is a Special Court specifically constituted to try 138 Cases keeping the complaint pending without taking it on file for more than 2 ½ is not proper, whatever may be the reason. Unless the complaint suffers from any defect or deficiency, it cannot be kept pending for any other reason.
