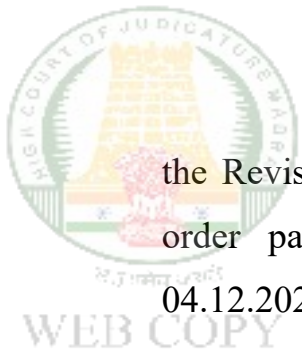

ORDER

respondent, notice to the 5th respondent is dispensed with by this Court in this Writ Petition.
