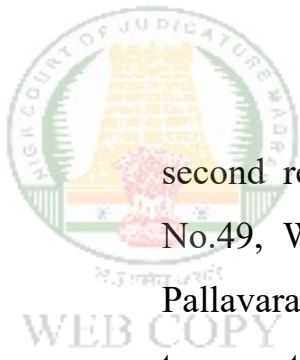

ORDER

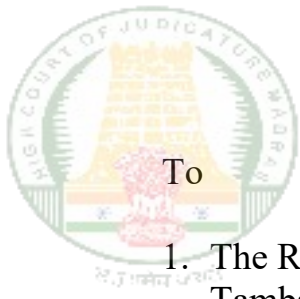
The learned counsel appearing for the petitioner seeks permission to withdraw this writ petition. He has also made an endorsement to that effect in the case bundle.
