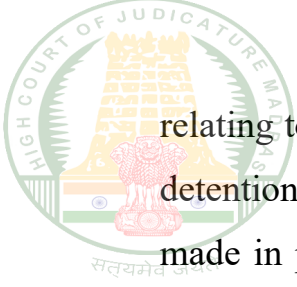

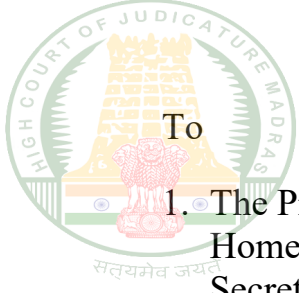
Order
