This writ petition has been filed to direct the respondents to consider the petitioner's representation dated 30.01.2026.

2. Mr.B.Pachaiyappan, learned Government's counsel, takes notice on behalf of the respondents.

3. By consent of the parties, the main petition is taken up for disposal in the stage of admission itself.

The learned counsel for the petitioner would submit that in this case, the petitioner filed a representation dated 30.01.2026 before the respondents, requesting for classification of DC agricultural land to Non DC Land comprised in Survey No. 146/2A1C, 146/2A3, 146/2B1, 146/2B3, 146/2A1A and 146/2A1B totally measuring an extent of 2.11 acres at Kolathur Village, Tiruvannamalai District. However, the said representation was not at all considered by the respondents till date. Hence, this petition.

5. In reply, the learned counsel for the respondent would submit that the petitioner's representation will be disposed of within a period of 12 weeks and hence, she requests this Court to pass appropriate orders.



6. Heard the learned counsel appearing for the petitioner as well as the respondent and also perused the entire materials available on record.
