On the said direction, the 6th respondent also conducted enquiry and submitted a report before the 1st respondent. On the basis of the said report, the respondents 1 to 3 will initiate necessary action as against the accused in accordance with law.



3. This Court, therefore, directs the respondents 1 to 3 to take appropriate action as against the accused on the basis of the report submitted by the 6th respondent in accordance with law, within a period of twelve (12) weeks, from the date of receipt of a copy of this order.
