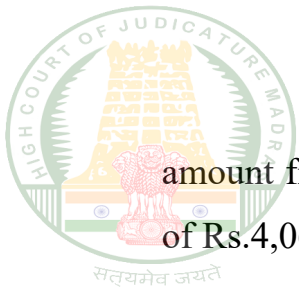

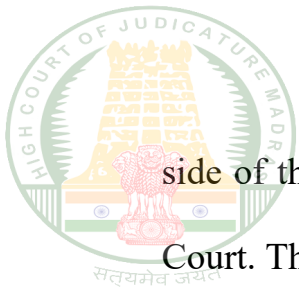

ORDER

2. Heard Mr.D.Pradeep Kumar, learned counsel for the applicant.

3. Service of notice on the respondents through Court is awaited. However, Affidavit of Service filed by the applicant, enclosing the acknowledgment card, indicates that notice had been duly served on the respondents. The names of the respondents have also been printed in the cause list today and when the matter was taken up, there is no representation on the



side of the respondents neither through counsel nor did they appear before this Court. They are called absent and set *ex-parte*.
