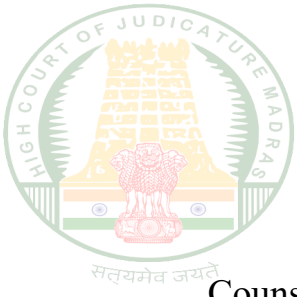
With consent, the main Writ Petition is taken up for disposal at the stage of admission itself.

2. This Writ Petition is filed seeking for following prayer:-

For issuance of a mandamus directing the 2nd respondent to admit and register the sale deed assigned with a temporary number TP/264429396/2026 with respect to above said property.

3. Learned counsel for the petitioner would submit that the petitioner has approached the second respondent for registration of a document however, the second respondent refused to register the same, hence, the present Writ Petition.

4. The learned Government Counsel who takes notice for the respondents1 and 2 would submit that the petitioner may be directed to present the document onceagain, which would be accepted by the second respondent and necessary steps would be taken for registration.
