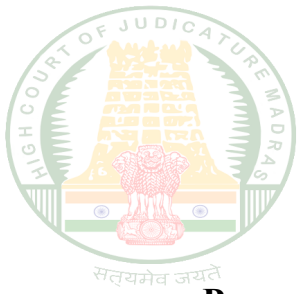

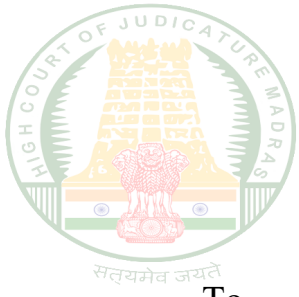

No prejudice will be caused to the respondents if the petitioners' representation, as stated supra, is considered on merits and in accordance with law after giving due consideration to the supporting documents produced by the petitioners within a time frame to be fixed by this Court. This Court is not expressing any opinion on merits of the petitioners' representation.

5. For the foregoing reasons, this Writ Petition is disposed of by directing the fourth respondent to pass final orders on merits and in accordance with law on the petitioners' representation, dated 11.03.2026 seeking for issuance of house site patta in the respective names for the respective properties more fully disclosed in the affidavit filed in support of this Writ Petition, after giving due consideration to the supporting documents produced by the petitioners and after hearing all the necessary parties, within a period of 12 weeks from the date of receipt of a copy of this order. There shall be no order as to costs. W.M.P.No.17610 of 2026 is ordered subject to payment of separate Court fee.
