This Writ Miscellaneous Petition is filed seeking to implead the petitioner herein as proposed respondent/6th respondent in WP.No.4609 of 2026.

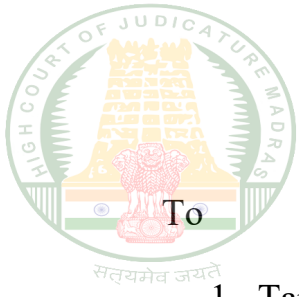
2.The learned counsel for the writ petitioner/first respondent herein, would submit that he has no objection to the petition for impleadment being ordered.
