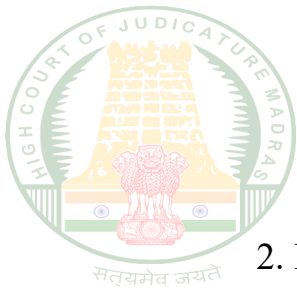

2. Heard the learned counsel for the petitioner and learned counsel for the respondent.

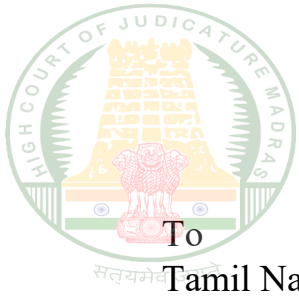
3. The learned counsel for the respondent has no serious objection.
