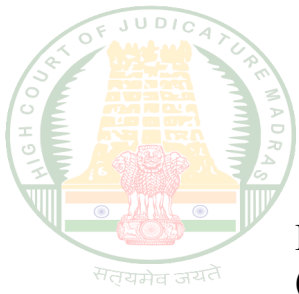

COMMON ORDER

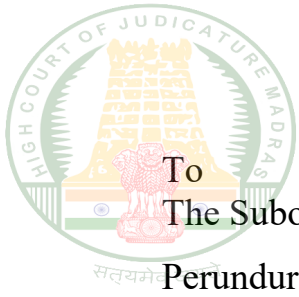
