c) A Mandatory injunction directing the defendant to remove/ delete the false defamatory video/ audio dated 31.03.2026 or any other material or statements aforesaid including displaying the brand name of the plaintiff namely GOLD WINNER in all online media including but not limited to X,, Facebook, Instagram, Youtube, and Whatsapp.
