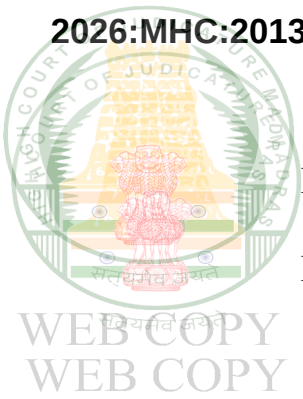

ORDER

(Order of the Court was made by Dr.Anita Sumanth J.)

Read this order in continuation of and in conjunction with previous orders dated 02.06.2026, 03.06.2026 and 05.06.2026 reading thus:-

'Order dated 02.06.2026:

The detenue appears online today and states that she is in a Hostel in T.Nagar. She, however, does not give her address but assures the Court that she will present in Court with R3, with whom she is married.

2. List on 03.06.2026 at 12.00 noon.

Order dated 03.06.2026:

The detenue and R3 appears in Court today and we have conversed with them. They say that they are married and are apprehensive about the pressure exerted by the petitioner and family members.

2. List on 05.06.2026 at 12.00 noon. We dispense with the appearance of detenue and R3 physically though they should be present online. The petitioner, her husband, brothers and family members will be present in Court on the next date of hearing.

Order dated 05.06.2026:

The petitioner is not present in Court and the learned counsel appearing on her behalf says that she is unwell.

2. List on 08.06.2026 at 12.00 noon. We reiterate the direction under order dated 03.06.2026 for appearance of the petitioner, her husband, brothers and family members, at least online on the next date of hearing.'



2. Both the family members of the detainee and the detainee have logged into the proceedings, they have also conversed briefly with each other. We have advised the detainee to speak to her family members periodically.

3. Since the detainee's date of birth is 13.10.2007 and she is a major, there is nothing more to be said in the matter. Recording the same, we close this Habeas Corpus Petition. No costs.
