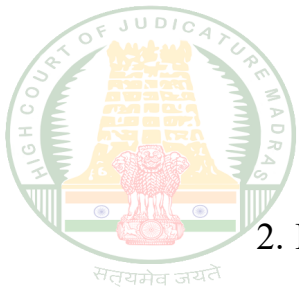

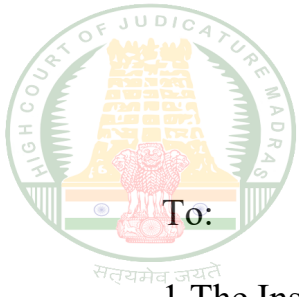
4. Accordingly, the Criminal Miscellaneous Petition is ordered.
