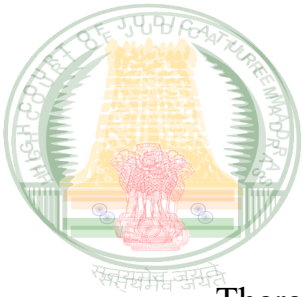

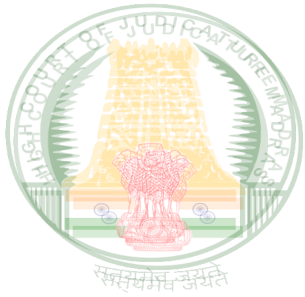
3. With the above direction, this writ petition is disposed of.
