by learned counsel for petitioner as well as fourth respondent.

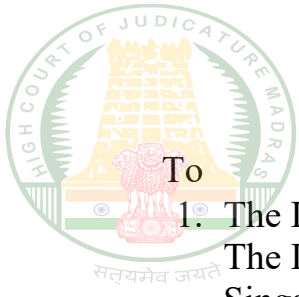
