2. Heard the learned counsel appearing on either side and perused the materials available on record.

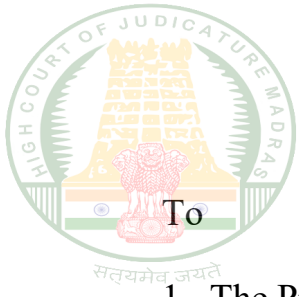
