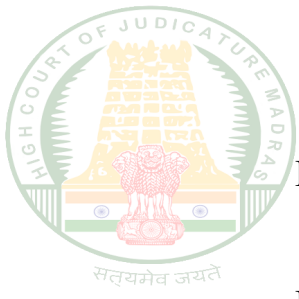

ORDER

This Writ Petition has been filed to direct the respondents to consider the petitioner's representation dated 07.04.2026.

2.
