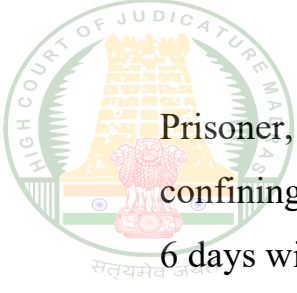

'Petitioner has made a representation on 05.05.2025 seeking ordinary leave which is under consideration. Let orders be passed prior to the next date of hearing.

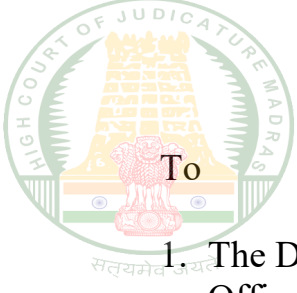
2.List under the caption 'for production of orders' on 11.06.2026.'
