2. In view of the above, this writ petition is dismissed as withdrawn. No costs. Consequently, connected miscellaneous petition is closed.

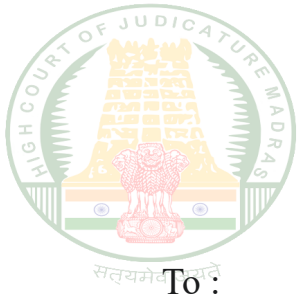
