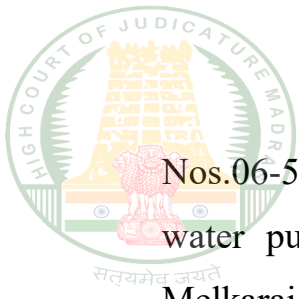

PRAYER:- Writ petition filed under Article 226 of the Constitution of India, praying for an issuance of Writ of Mandamus, directing the respondents particularly 3rd respondent to consider the petitioner's representation dated 10.02.2026 to transfer of TSLR patta in favour of the petitioner for the land comprised in comprised in ward No.3, Block No.27, Town Survey No.1208 measuring an extent of 1168.5 square meters, together with all buildings and structures thereon. The property includes residential buildings bearing door Nos.104, 104/A1, 104/A2, 104/A3, 104/A4, 104/B, 104/C, 104/D, 105/A, 105/D and 106 along with terrace and tiled constructions, together with all appurtenances attached thereto, including Electrical service connections bearing



Nos.06-562-002-0539, 197, 501, 538, 1421, 540 and 1516 1/2 HP motor and water pump sets, three coconut trees sanding on the property situated at Melkarai (Facing Thiruthuraipoondi Road) Vijayapuram Gandhi Road, Within the limits of Vijayapuram Village, Tiruvarur Town, Tiruvarur District, and within the jurisdiction of the Sub Registrar office, Tiruvarur.

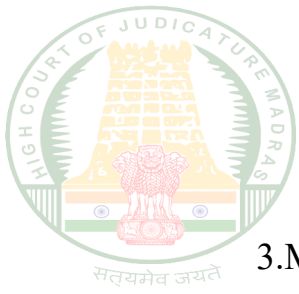

Order

This writ petition has been filed seeking to direct the respondents particularly the 3rd respondent to consider the petitioner's representation dated 10.02.2026 and to transfer the TSLR patta in favour of the petitioner for the land comprised in ward No.3, Block No.27, Town Survey No.1208 measuring an extent of 1168.5 square meters, together with all buildings and structures thereon.

2.Learned counsel for the petitioner would submit that the petitioner made a representation dated 10.02.2026 seeking to mutate the TSLR patta in the name of the petitioner in respect of the property comprised in ward No.3, Block No.27, Town Survey No.1208 measuring an extent of 1168.5 square meters, together with all buildings and structures thereon. However, the said representation was not considered by the respondents. Hence, the present writ petition has been filed.

4. Heard the learned counsel for the petitioner as well as the learned Government's Counsel appearing for the respondents.

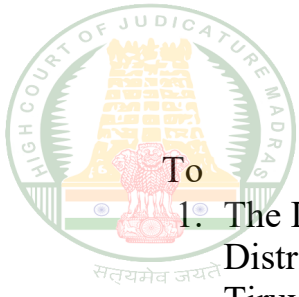
