2. Accordingly, the writ petition is dismissed as withdrawn.

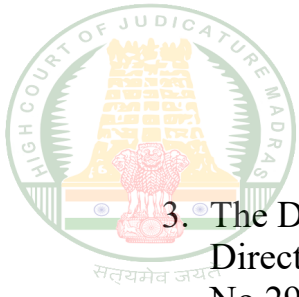
