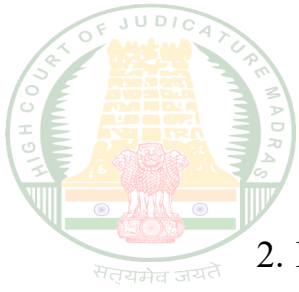
Prayer: This writ petition is filed under Article 226 of the Constitution of India, praying to issue a Writ of Mandamus directing the respondent to consider and dispose of petitioner's application dated 09.09.2022 bearing Application No.582 for transfer of patta and issuance of patta in respect of the property situated at Old SF No.96, 97, 98, 99, 100 admeasuring to an total extent of 1.50 acre at Chennasandaram Village, Hosur Taluk within the Sub Registration district of Hosur and Registration district of Krishnagiri.

This Writ Petition has been filed to direct the respondent to consider the petitioner's online application dated 09.09.2022.

Learned counsel for the petitioner would submit that the petitioner has made an online application dated 09.09.2022 to transfer the patta on his favour in respect of the property situated at Old SF Nos.96, 97, 98, 99 & 100 admeasuring to an extent of 1.50 acre at Chennasandaram Village, Hosur Taluk within the Sub Registration District of Hosur and Registration District of Krishnagiri. However, the same was not considered, as on date. Hence, this writ petition.

3. Mr.B.Pachaiyappan, learned Government's Counsel accepts notice on behalf of the respondent and submitted that the petitioner's application dated 09.09.2022 will be considered within a period of twelve weeks.

4. Heard the learned counsel on either side and perused the materials available on record.

Considering the limited relief sought by the learned counsel for the petitioner, this Court without expressing any opinion on the merits of the case, directs the respondent to dispose of the petitioner's online application dated 09.09.2022 on merits and in accordance with law, within a period of twelve (12) weeks from the date of receipt of a copy of this order.
